AMENDMENT TO DECLARATION OF CONDOMINIUM AND BYLAWS OF MARINA CLUB VILLAGE CONDOMINIUM

WHEREAS, Marina Club Village Condominium Association, Inc. a Florida Corporation, having its principal office at 100 Delwood Beach Road, Panama City Beach, Florida submitted certain lands located in Bay County, Florida, to condominium ownership by virtue of that certain Declaration of Condominium of Marina Club Village, a Condominium; and

WHEREAS, said Declaration designated Marina Club Village Condominium Association, Inc. as the Association of the membership of said condominium; and

WHEREAS, the Bylaws of the aforementioned Association were made a part of the Declaration of Condominium of Marina Club Village, a Condominium; and

WHEREAS, at a special meeting of the members/unit owners of the Association held the 1st day of February, 1997, more than two-thirds (2/3) of the voting members of the Association approved the amendments to the Bylaws, Prospectus and Declaration of Condominium.

NOW, THEREFORE, the Bylaws, Prospectus and Declaration of Condominium of Marina Club Village, a Condominium, are hereby amended by vote of more than two-thirds (2/3) of the voting members of the Association as follows:

- 1. There is a substantial rewording of Paragraph 13 of the Prospectus of Condominium of Marian Club Village, a Condominium. Paragraph 13 of the Prospectus of Condominium of Marina Club Village, a Condominium, is hereby deleted in its entirety and the following is substituted therefor:
- 13. <u>Utilities and Services</u>. Utilities and other services are supplied to the condominium as follows:
- (a) Sanitary sewer through City of Panama City Beach, contracted directly with each Unit Owner and the City.
- (b) Refuse collection through the Association by contract with the Master Association.
- (c) Water supply through the City of Panama City Beach, contracted directly with each Unit Owner and the City.
 - (d) Electricity through Gulf Power Company.
- (e) Telephone through phone company as determined by each individual Unit Owner.
- (f) Cable Television through the Association by contract with the cable television company.

The estimated charges for refuse collection and cable television are included in the monthly assessments payable to the Association. All unit owners will deal directly with the providers of water, sewer, telephone and electricity.

2. There is a substantial rewording of Paragraph 15.11 of the Declaration of Condominium of Marina Club Village, a Condominium. Paragraph 15.11 of the Declaration of Condominium of Marina Club Village, a Condominium, is hereby deleted in its entirety and the following is substituted therefor:

15.11 <u>Utility Assessments</u>

All Unit Owners shall contract separately with private providers for water, sewer, telephone service and electricity. The Association shall provide to the Unit Owners

refuse collection and cable television and shall have the power to and shall include an adequate charge in the monthly assessments to Unit Owners to cover the cost associated with providing refuse collection and cable television.

3. These Amendments to the Declaration of Condominium and Bylaws of Marina Club Village, a Condominium, were approved at the special meeting above described by owners of not less than two-thirds (2/3) of the Units and the votes to make these amendments were duly recorded in the Minutes of the above-described meeting of the Unit Owners.
